

The Community State Bank “Race for the Ranger” Scavenger Hunt Sweepstakes
Official Rules

- 1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO WIN. APPLYING FOR A LOAN OR OPENING A COMMUNITY STATE BANK ACCOUNT WILL NOT INCREASE YOUR ODDS OF WINNING.** No submission of personal financial data, including bank account or credit card information, personal income, or other financial data, is necessary to enter or win. **VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.**
- 2. SWEEPSTAKES PERIOD.** The scavenger hunt begins at 9:00 AM (Central Time) on Monday, September 14, 2020 and ends Thursday, October 15, 2020 at 3:00PM (“Sweepstakes Period”). A clue will be posted to the Community State Bank Facebook account and on the Main Bank front doors each day (excluding weekends and holidays) at 9:00AM and the last clue will be posted at 9:00AM on Tuesday, October 13, 2020. There will be a total of twenty one (21) clues posted during this contest period. All completed entries must be completed and turned into the Main Bank no later than 6:00PM on Thursday, October 15, 2020. Entries received after this time will not be accepted.
- 3. TO ENTER.** To enter this sweepstakes, participants must pick up the entry form at the Main Bank in Poteau on or after 9:00AM Monday, September 14, 2020. Limit of one (1) prize per contest period per household. The Community State Bank reserves the right, at its sole discretion, to reject any entry. By participating in the scavenger hunt, participants agree to abide by these Official Rules.
- 4. WINNING; ODDS.** Each entry must locate and correctly identify the given clue each day during the contest. After all clues are given, contestant must correctly determine the phrase the clues represent. Each correctly completed entry form turned in before deadline will be entered into a drawing. Odds of winning the Grand Prize depend on the number of participants, but all correct entries turned in will win a prize. All decisions of this sweepstakes are final, binding, and non-negotiable.
- 5. ELIGIBILITY.** This sweepstakes is open to legal residents of the United States who are ages 18 years or older at the time of entry. Employees & Directors of The Community State Bank, or people living within such
